(1) The other financial corporations sector (OFCs) is comprised of all financial business subsectors other than the monetary authority, private depository institutions, and money market funds, as presented in the Financial Accounts of the United States. Claims on and liabilities to OFCs are consolidated and therefore not included in these data.

(2) Liabilities include deposits, debt securities, loans, and insurance, pension, and standardized guarantee schemes. Other, non-equity claims on OFCs are included in line 13, other items (net).

(3) Depository corporations are private depository institutions, money market funds, and the monetary authority.

(4) Other resident sectors are the nonfinancial business sector and household and nonprofit organizations sector.

(5) Includes equity holdings of nonresidents.
